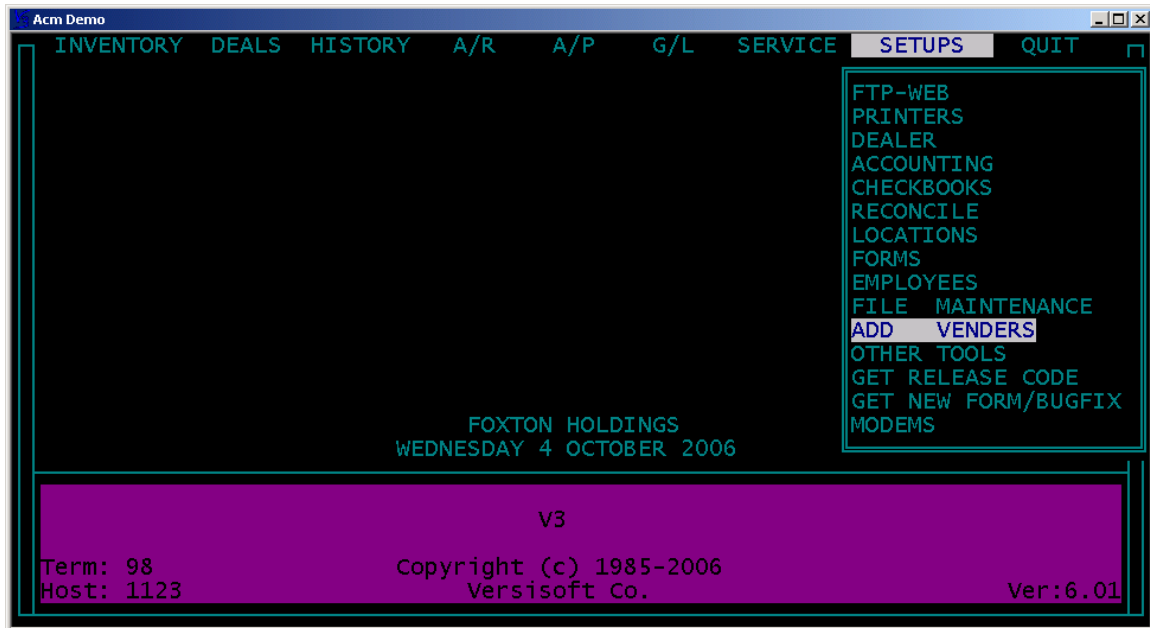
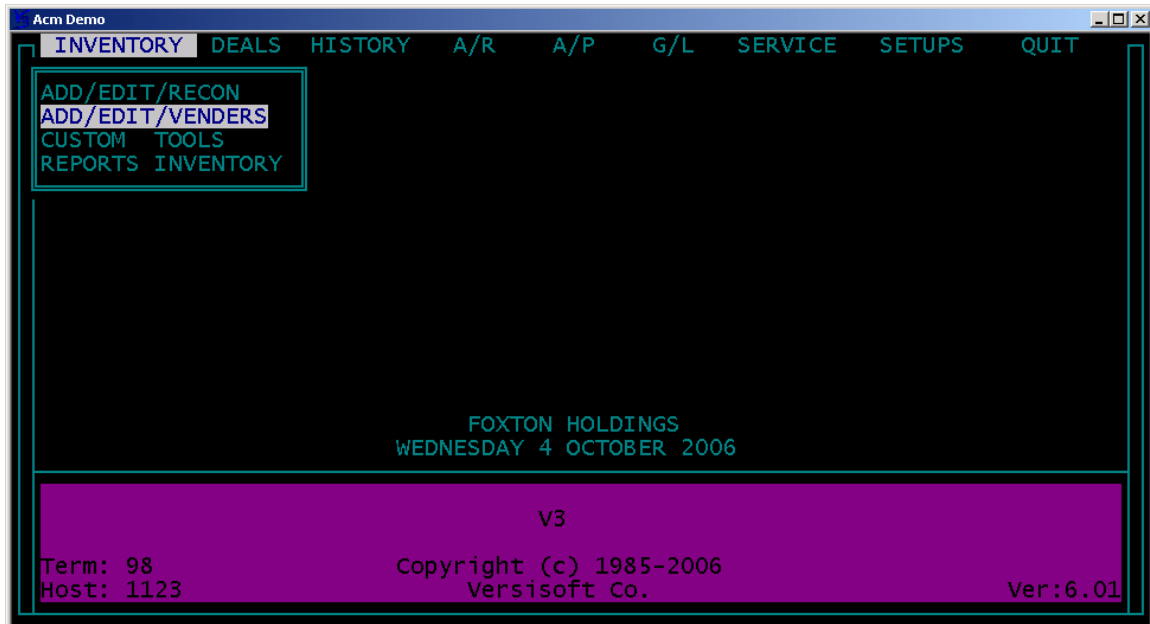




SETUP ADD VENDERS



The **VENDOR** module controls the files that are used in **INVENTORY**, **WHOLESALE DEALS**, and any of the standard Retail workbenches to pull over the name, address, telephone, dealer and tax numbers used by these modules. The **VENDOR** module will be your directory for all vendors used such as to pay bills, buy cars, sell wholesale cars, and recon vendors.



The vendor files may be accessed from **SETUPS** or **INVENTORY**.

EDIT VENDOR: This menu selection allows you to edit a current vendor file. To edit a vendor; **FIND VENDOR** and with the target vendor on screen highlight **EDIT VENDOR** and press enter to edit each field.

ADD VENDOR: Highlight and press enter on **ADD VENDOR**. Enter the new vendor information in each field.

NAME: Enter the vendor name how it should appear on checks, purchase orders, etc.

ADDRESS, CITY, STATE, ZIP: Enter the vendor address how it should appear on checks, purchase orders, etc.

DEBIT REF: Enter the default debit account to be used for this vendor in the **PAYABLES** Module.

CREDIT RF: Enter the default credit account to be used for this vendor in the **PAYABLES** Module.

POS LEVEL: This field allows you to set discount levels in the Parts and Service module.

TAXED Y/N, TAX RATE: These fields allow you to set defaults for this vendor in Parts and Service module.

STATE TIN, FEDERAL TAX#, CORP Y/N: These fields allow you to set up the 1099 parameters.

ZAP VENDOR: This menu selection deletes the vendor file.

EXIT TO MAIN: Exits you to the main menu.
